# Gift Aid Information (updated 1 May 2016)

### What is Gift Aid

If you are a UK taxpayer, then HM Revenue & Customs (HMRC) operates a scheme called **Gift Aid** which allows charities to reclaim your tax on donations you make to them. This includes your sponsorship for this event.

Currently the standard rate of tax is 20% so if you donate £10 from your taxed income, this is treated as if you had donated £12.50 before tax. Pageant is able to claim £2.50 from HMRC, meaning that currently all donations which qualify for Gift Aid are worth 25% more to us.

## Information about Gift Aid for sponsors

If you provide your full name, address and postcode, and then tick the 'Gift Aid' column, you will be agreeing to Pageant claiming Gift Aid on your donation.

- Your name should be the one you use for tax purposes. HMRC require your surname and either your first name or your initials.
- Your address must be that which you use for tax purposes. HMRC need at least a house number and postcode.
- You must make sure that the total amount of Gift Aid which is reclaimed by ALL charities and CASCs you donate to in any tax year does not exceed the amount of tax you pay in that year. (CASC means Community Amateur Sports Club)
- VAT and Council Tax do not qualify.
- If you pay less Income Tax and/or Capital Gains Tax in the current tax year than the amount of Gift Aid claimed on all your donations, then it is your responsibility to pay any difference.
- If you pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask HM Revenue and Customs to adjust your tax code.

### Information for the fundraiser

Please use separate forms if you have more than 15 sponsors. If a sponsor is Gift Aiding their donation, please ensure that they have filled in their full name, address and postcode, and ticked the Gift Aid column. On each form, insert the total amount received from the sponsors on that form and the total for all Gift Aided donations. When you hand over the money to Pageant, please insert the date of the handover on every form and give all the forms to Pageant.
